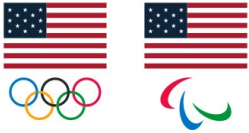


**2021 Impact Report Summary**  
**Litigation and Grievances Filed Against the USOPC**  
*Status of matters current as of December 31, 2021*

No lawsuits or grievances were filed against the USOPC in calendar year 2021. The four below-captioned lawsuits contained in the 2020 Impact Report Summary were fully resolved in calendar year 2021, and the remainder are still pending a final resolution or outcome.<sup>1</sup>

<sup>1</sup> With respect to the lawsuits related to Dr. Larry Nassar and USA Gymnastics contained in the 2020 Impact Report Summary, a global settlement was reached in the USA Gymnastics bankruptcy proceeding to resolve all abuse claims in December 2021 pursuant to a joint plan of reorganization (“Joint Plan”). The Joint Plan became effective on April 25, 2022, at which time the global settlement was funded. Settlement distributions are set to be underway, and plaintiffs must dismiss their lawsuits with prejudice within ten days after receiving their settlement distributions.
